GSAFE strives to assure that each member of every school community is valued and respected regardless of sexual orientation or gender identity/expression. We believe that such an atmosphere engenders a positive sense of self, which is the basis of educational achievement and personal growth. Since homophobia and heterosexism undermine a healthy school climate, we work to educate teachers, students and the public at large about the damaging effects these forces have on youth and adults alike. We recognize that forces such as racism and sexism have similarly adverse impacts on communities and we support schools in seeking to redress all such inequities. GSAFE seeks to develop school climates where difference is valued for the positive contribution it makes in creating a more vibrant and diverse community. We welcome as members any and all individuals, regardless of sexual orientation, gender identity/expression or occupation, who are committed to seeing this philosophy realized in K-12 schools.

GLSEN Greensboro is an all volunteer organization with no paid staff. We would focus on putting fictional books portraying positive images of GLBT individuals and resource books in schools in Guilford County. Annette Green is our librarian and handles cataloging and checkout of resources in our GLSEN Resource Library.

C. If Grantseeker were to receive a Guilford Green Foundation grant for the particular initiative, project or activity described in (IV.A) above, what outcome is envisioned? What accomplishments or changes may result?

One of the major needs of young GLBT individuals has been to see positive portrayals of themselves in media, including books, movies, etc. Most schools have few, if any books that give a positive portrayal of GLBT individuals. Having positive portrayals in our schools allows students to understand that they are recognized and can be appreciated in our culture. It makes them less invisible and less isolated. A GSA student told an incident to us about a friend of hers who went into her library and was pleased and surprised to find a book with GLBT characters. This would have been one of the few positive portrayals she had encountered.

D. What tools or measures will you apply to evaluate the success or failure of a Guilford Green Foundation grant?

Having GLBT positive books on the shelves in school libraries will be a success. Availability of items in our GSAFE Resource Library will constitute success.
